




# Hunt Club

## POOL RULES Revised Jun 28 2016

1. NO GLASS allowed in the pool or on the deck.
2. NO ANIMALS OR PETS allowed in the pool.
3. An inexperienced swimmer must be accompanied by an EXPERIENCED SWIMMER.
4. NO PERSON UNDER THE INFLUENCE of alcohol or drugs should use the pool.
5. This pool is OPEN from sunrise to sunset.
6. The MAXIMUM number of swimmers allowed in the pool is 100.
7. There should be NO SOLO SWIMMING.
8. There should be NO RUNNING, BOISTEROUS OR ROUGH PLAY.
9. There should be NO SPITTING OR BLOWING NOSE in pool.
10. Persons with diarrheal ILLNESS OR NAUSEA SHOULD NOT ENTER the pool.
11. Persons with SKIN, EYE, EAR OR RESPIRATORY INFECTIONS SHOULD NOT ENTER the pool.
12. Persons with OPEN LESIONS OR WOUNDS SHOULD NOT ENTER the pool.
13. You should take a SHOWER BEFORE ENTERING the pool.
14. A FIRST AID KIT is located in the women's bathroom.
15. Life saving equipment is located on the fence by the gate.
16. An EMERGENCY PHONE (or other notification device) is located by the bathroom doors.
17. The pool operator of record at this facility is Sweetwater Pools – Charleston, LLC – State Certification Number 37-281730.
18. No grills allowed inside the fenced in pool area.
19. No smoking is permitted inside the fenced in pool area.
20. Homeowners may sponsor a single family or up to six (6) family members or friends as guests at the community pool. The term “single family” is defined as a family consisting of parent(s) and children of their household up to a total of six (6) persons. Sponsoring homeowners are responsible for and will be held accountable for the behavior and actions of all sponsored and their adherence to the pool rules. An adult member of the sponsoring family shall accompany their guests. Parties must be approved in advance by Management.
21. Reusable plastic swim pants over diapers or a disposable swim pant (e.g. Huggies Little Swimmers or equal) are required for children who are not potty trained. The cost (\$25.00 minimum) for additional chemical treatment will be assessed against the owner for related accidents and mandatory pool closure.
