**A RESOLUTION OF THE BOARD OF DIRECTORS
TO CLARIFY VEHICLE PARKING RULES**

WHEREAS, Exhibit C, Paragraph 1(a), to the Declaration of Covenants, Conditions, and Restrictions for Hunt Club Residential Zone (“Declaration”), establishes rules regulating the parking of vehicles in places other than driveways and enclosed garages “**over an extended period of time**” except as may be otherwise designated by the Board of Directors (“Board”); and

WHEREAS, it is the intent of the Board to clarify the permissible parking of vehicles and to promote the safety of Members and their guests;

NOW, THEREFORE, BE IT RESOLVED that the Board does hereby clarify Paragraph 1(a), Exhibit C, Initial Use Restrictions and Rules as follows:


The term “extended period of time” as used in Paragraph 1(a) shall mean more than four (4) continuous hours or five (5) total hours in a twenty-four (24) hour period, or on a recurring basis.
